## **1. Introduction**

Andhra Pradesh State FiberNet Limited (APSFL) has been incorporated under the Companies Act 2013 in October 2015, to undertake the works of AP Fiber Grid, its operations & maintenance and related business activities. It is a fully owned entity of the Government of AP under the control of Energy Department. APSFL aims to provide high quality & affordable digital services to households, government departments and enterprises across the State.

Fiber Grid is primarily aimed at harnessing the power of information resource and enabling provision of qualitative and cost-effective IT, Communication (data, voice & video) and other related services to the citizens of A.P.

Vision of AP Fiber Grid is as follows:

“To establish a highly scalable network infrastructure, accessible on a non-discriminatory basis, to provide on demand, affordable and end-to-end broadband connectivity of 15 Mbps for all households and 100 mbps to 1 Gbps or more for institutions & multi-dwelling units, to enable realization of the Vision of Digital Andhra Pradesh, in partnership with the Government of India and Private Sector.” In line with the vision, a dual phased approach has been undertaken to deliver the project mandate in AP.

Phase I – Aerial Fiber Grid Network will create an aerial fiber network up-to Mandal level by leveraging assets of Electricity companies.

Phase II - Aerial Fiber network covering the entire State upto Gram Panchayats level.

Phase I of the Project (Aerial Fiber grid project), APSFL has established state-wide high speed optical fiber network infrastructure covering approximately 23,000 kms route across the 13 districts of Andhra Pradesh through 2449 PoPs being operated and controlled from Network Operations Centre (NOC) setup in Vishakhapatnam. Phase I project components include laying aerial optical Fiber across the State upto mandal level, so that the State, District, Zonal and Mandal's are connected with each other using ring topology as much as possible. In addition, the last mile connectivity is to be made available through a network of MSOs/ LCOs.

APSFL has already procured the required CPE (customer premise equipment) boxes in order to deliver the Triple Play Services viz., IPTV, high-speed Broadband and Telecom. Online enrolment of MSOs/LCOs for business association with APSFL have been done and has already extended Triple Play Services to thousands of customers.

To maintain the day to day maintenance activities of AP Fiber Grid Phase- I and to establish new enterprise connection, viz., Government offices, Private organisations, village ward secretariats, panchayats, Gram Sachivalayams, PHCs, schools, Rythu bharsa Kendras and ITDA projects APSFL plans to procure 6F ADSS (All- Dielectric Self Supporting) Optical Fiber cable.

## **2. Scope of Work**

To maintain day to day maintenance activities of AP Fiber Grid Phase- I and to establish new enterprise connection, viz., Government offices, Private organisations, village ward secretariats, Panchayats, Gram Sachivalayams, PHCs, Schools, Rythu Bharosa Kendras and ITDA projects.

Andhra Pradesh State FiberNet Limited intends to empanel the vendors for procurement of 6F ADSS (All-Dielectric Self Supporting) Optical Fiber cable and will be placed orders upto 10Cr value of fiber cable as per requirement.

APSFL has finalized the standards & specifications for 6F ADSS (All- Dielectric Self Supporting) Optical Fiber cable in this DOCUMENT. The bidders were instructed to compile all parameters.

This empanelment is valid for **two years** of operation and the same will be extended for further periods on a mutually agreeable basis between APSFL and vendors. APSFL reserves the right to extend the contract beyond one year.

The Empanelment of Vendors for procurement and the finalization of the vendors will be done as per the Selection Process mentioned in this DOCUMENT

## **Sample Testing Phase & Acceptance Phase**

The qualified Bidder(s) have to submit the sample of 4 Kms of 6F ADSS (All- Dielectric Self Supporting) Optical Fiber cable for which they have been short listed for testing and the cable has to comply for all the standards & specifications given in the DOCUMENT and any other compliance that are deemed necessary for delivery of quality services to the end users. Bidder should submit samples of cable as proposed with their feature test reports along with the bid. Testing of the samples should be completed within fifteen (15) days from the date of submission of bid. In case bidder fails to submit the samples along with bid (or) fails to submit successful test reports within the stipulated time, such bids will be rejected

## **3. General Instructions to Bidder**

- a) The LOA will be issued only to the Bidder(s) who are qualified as per the requirements of the DOCUMENT.
- b) The applicant should submit all the necessary documents/proofs/declarations as per the requirements of this DOCUMENT in prescribed formats to record their participation and facilitate the evaluation process.
- c) Proposals without necessary supporting documents or without meeting the prescribed qualification criteria will be treated as non-responsive and will not be considered for further evaluation.
- d) The Authority reserves the right to cancel the DOCUMENT without assigning any reason to the applicants(s)
- e) The Authority reserves the right to request for any document/clarification from the applicant(s) which the authority fees that it is required to facilitate the evaluation process.
- f) The successful bidder should nominate a Single Point of Contract (SPOC) for all the transactions to be executed with APSFL.

- g) APSFL shall not be held responsibility in the event of unforeseen circumstances such as where Empanelment is cancelled due to various Government decisions.
- h) All the Bidder(s) must adhere to the TRAI Guidelines.

- b. Bidders are required to provide the aforementioned information as per the formats provided along with the required supporting documents for each of the criteria mentioned above.
- c. APSFL will empanel the vendors who have fully complied with the eligibility criteria and the sample acceptance as per the specifications.
- d. The shortlisted bidders will be notified through Email. For completing the empanelment process, the successful bidders will have to submit a One-time Registration Fee of INR 3,00,000/- (Rupees three Lakh Only) within a period of 7 days from the date of receipt of confirmation on empanelment.

## **41 Empanelment**

- a) The agencies shortlisted for empanelment will be required to sign an Agreement with APSFL, accepting the terms and conditions laid down by APSFL. After signing of the agreement, no variation or modification in the terms of the agreement shall be made except by written amendment signed by both the parties.
- b) The empanelment shall be initially for a period of two years from the date of issuance of LOA to the shortlisted agency(s). It can be extended through mutual consent based on the requirement of APSFL. APSFL shall be free to cancel the empanelment at any time during the period of engagement between APSFL and the shortlisted agency, without assigning any reason.

## 42 Allocation of Work

- The present DOCUMENT is exclusively for empanelment of cable vendors only. For allocation of purchase order, APSFL will circulate work specific RFQ / Service Request with defined scope and expected deliverables among the empanelled agencies and invite quotations to award the work based on the Least Total Cost(L1) received
- The selected agency shall not assign the project / work to any other agency, in whole or in part, to perform its obligation under the agreement.
- Mere empanelment with APSFL does not guarantee allocation of work
- In case, when the time period is too short to complete the work or in case of any ad-hoc requirement, the work may be entrusted to any of the empanelled agencies or any other agency which APSFL deems to meet the deadline.
- The payment terms and commercial conditions for each work will be as per the service request floated by APSFL for the specific work
